

ORDINANCE 10, 1977

AN ORDINANCE ESTABLISHING NO PARKING AREAS ON PUBLIC STREETS WITHIN THE CIVIL TOWN OF MOORESVILLE, MORGAN COUNTY, INDIANA

BE IT ORDAINED, by the Board of Trustees of the Civil Town of Mooresville, Morgan County, Indiana, that

By the Powers vested in the Board of Trustees of the Civil Town of Mooresville, Morgan County, Indiana, by the Acts of the General Assembly of the State of Indiana, as the same have been adopted and amended from time to time, it is hereby ORDERED AND ORDAINED that whereas it is necessary to control the flow and passage of traffic on certain streets in the Civil Town of Mooresville, Morgan County, Indiana, in order to provide safe passage for all types of emergency vehicles and other traffic using the following designated streets, and for the purposes of being able to provide snow removal for citizens in said area, no parking zones shall and are no established on the following designated streets, or parts thereof, and it is hereby ORDERED AND ORDAINED that an ordinance be adopted providing no parking on and along said areas of the following streets as shall be defines in the following Section I, to-wit:

Section I

IT IS HEREBY ORDERED AND ORDAINED for the general flow of traffic on the following designated streets and for the safe passage of all types of emergency vehicles using the following designated streets, there is hereby established a no parking zone, and no parking shall be permitted at any time and along the following right-of-ways of the following dedicated streets, to-wit:

1. On the south and east right-of-way of Brentwood Drive from Indianapolis Road to its termination at St. Clair Street.
2. On the south right-of-way and west right-of-way of Crestwood Drive, from its beginning point on Indianapolis Road to its termination at Greenwood Drive.

3. On the south right-of-way of Greenwood Drive from its beginning point at Crestwood to its termination with Maple Lane.
4. On the west right-of-way of Arlington Drive from its beginning point at St. Clair Street north to its intersection with Crestwood Drive.
5. On the west right-of-way of Maple Lane from its intersection at St. Clair Street north to its termination at North Drive.
6. On and along the south right-of-way of North Drive
7. On and along the east right-of-way of Center Lane
8. On and along the east right-of-way of Morningstar Drive
9. On and along the south and west rights-of-way of Sunset Manor from its beginning point on Morningstar Drive as it meanders south and east to its termination point on Maple Lane.
10. On and along the north right-of-way of Sunbury Drive
11. On and along the south right-of-way of Holiday Lane
12. On and along the west right-of-way of Westbrook Drive from its beginning with Devonwood Drive south to its termination with Holiday Lane.
13. On and along the south right-of-way of Williams Drive
14. On and along the north right-of-way of Fairlane Drive from its beginning point with Westbrook Drive west to its termination with Edgewood Drive.
15. On the west and south right-of-way of Dunn Drive as it meanders south and east from Fairlane to its termination at Edgewood Drive
16. On the east right-of-way of Edgewood Drive from its beginning point at Holiday Lane north to its termination at Devonwood Drive
17. On the north right-of-way of Devonwood Drive from its beginning point at Edgewood Drive to its termination into Westbrook Drive.
18. On and along the north right-of-way of Northfield Drive from its beginning point at Indianapolis Road to its termination at Edgewood Drive
19. On and along the east right-of-way of Westwood Drive
20. On and along the east and north right-of-way of Delwood Drive as it meanders north and west from its beginning point on Northfield Drive, to its termination into Westwood Drive

21. On the north right-of-way of Sweetwood Drive
22. On and along the west right-of-way of Rose Lane
23. On and along the east right-of-way of Nelson Drive
24. On and along the north right-of-way of St. Clair Street from its beginning point at Indianapolis Road west to its termination with Maple Lane.
25. On and along the west right-of-way and south right-of-way of Church Street as it meanders north and west from its beginning point at St. Clair Street, to its termination at Indiana Street.
26. On and along the south right-of-way of Highland Drive

Section II.

The Town Marshal, or any other person designated by the Board of Trustees of the Town of Mooresville, Morgan County, Indiana, shall post or cause to be posted signs at the aforesaid no parking area, designating such areas as a “No Parking Zone”.

Section III.

Be it further Ordained by the Board of Trustees of the Civil Town of Mooresville, Morgan County, Indiana, that the Mooresville Town Marshal or any Deputy Marshal of the Civil Town of Mooresville, Indiana, is hereby authorized to tow away, or have removed and towed away by commercial towing service, any motor vehicle illegally parked in the above designated areas on the rights-of-way of the streets described in Section I.

That any such vehicle as shall be towed away for violating the provisions of this Ordinance, shall be towed away for violating the provisions of this Ordinance, shall be towed to a place of safe storage and shall not be returned to the owner of such motor vehicle, until such time as the owner pays reasonable commercial towing charge, and storage expense, if any, as may be determined under the circumstances; and in addition thereto, such owner of said vehicle shall pay such fines as shall be assessed for the parking violation as provided in Section IV.

Section IV

Violation of this Ordinance is hereby declared to be a misdemeanor, punishable by fines of not less than One dollar (\$1.00) nor more than Twenty-five dollars (\$25.00).

Section V

Whereas, an emergency exists, this Ordinance is declared to be in full force and effect from and after its passage, and all ordinances or parts of ordinances in conflict herewith, are hereby specifically repealed in whole or in part, and the Clerk-Treasurer is directed to publish said Ordinance for two (2) consecutive weeks.
