

ORDINANCE 10-2000

AN ORDINANCE ESTABLISHING A NO PARKING AREA ON THE SOUTH SIDE OF WASHINGTON STREET WEST OF THE INTERSECTION OF FRANKLIN STREET

WHEREAS, pursuant to the authority granted to the civil Town of Mooresville by its legislative body the Town Council to enact certain Ordinances to establish reasonable regulations for the protection of life, health, safety and the property of the citizens of the Civil Town of Mooresville;

IT IS HEREBY ORDERED AND ORDAINED THAT:

Section I. An Ordinance be adopted prohibiting parking on the South side of Washington Street west of the intersection of Franklin Street for a distance of seventy feet (70') from the point furthest west on Franklin Street where it intersects with Washington Street. Parking shall be prohibited in this seventy-foot (70') strip at all times and the area shall be established as a "no parking zone". No parking shall be permitted at any time within this seventy-foot (70') area.

Section II. The Police Chief, Street Commissioner or other person designated by the Town Council shall be responsible for posting or causing to be posted signs at the aforesaid no parking area designating such area as "no parking zone".

Section III. BE IT FURTHER ORDAINED by the Town Council for the Civil Town of Mooresville, Morgan County, Indiana that the Mooresville Police Department is authorized to tow away or have removed and towed away by a commercial towing service any motor vehicle violating this Ordinance in the above designated area on the Town of Mooresville right-of-way located on Washington Street as described in Section I. Any such vehicle towed for violation of the provisions of this Ordinance shall be towed to a place of safe storage and shall not be returned to the owner of such motor vehicle until such time as the owner pays a reasonable commercial towing charge, any storage expense as charged by the service contacted by the Town to remove the vehicle. In addition, the owner of the vehicle shall be subject to the fines set out in Section IV of this ordinance.

Section IV. Violation of this Ordinance is hereby declared to be punishable by a fine of not less than One Dollar (\$1.00) nor more than Twenty-Five Dollars (\$25.00).

Section V. Whereas an emergency exists, this Ordinance is declared to be in full force and effect from and after its passage and publication and all Ordinances and parts of Ordinances in conflict herewith, are hereby specifically repealed in whole or in part, and the Clerk/Treasurer is directed to publish said Ordinance as required by law.

Said Ordinance passed and adopted this 27th day of June 2000.
