

ORDINANCE No. 19-1992

**AN ORDINANCE ESTABLISHING A TWENTY MILE PER HOUR
ZONE ON CARLISLE STREET AND CERTAIN PORTIONS OF
NORTH INDIANA STREET**

BE IT ORDAINED by the Town Council of the Civil Town of Mooresville, Indiana, that:

By the powers vested in the Town Council of the Civil Town of Mooresville by Indiana Code, the Town is vested to enact certain ordinances that are directed to the health and safety of the citizens of the Civil Town of Mooresville.

WHEREAS, it is necessary to control the flow and speed of traffic in the Civil Town of Mooresville, Indiana, in particular on Carlisle Street and North Indiana Street in the proximity of the respective schools located in this area.

WHEREAS, it has been deemed necessary to enact an ordinance restricting the speed limit to twenty (20) mile per hour in said area, in particular from State Road 267 east on Carlisle Street to a point wherein Carlisle Street intersects with Indiana Street and then north on Indiana Street from this point to Williams Drive.

SECTION I.

BE IT HEREBY ORDAINED by the Town Council of the Civil Town of Mooresville that there shall be established a speed limit of twenty (20) miles per hour on Carlisle Street from State Road 267 east to the point wherein Carlisle Street intersects with Indiana Street and from Indiana Street from this point of intersection on Carlisle Street to Williams Drive and no vehicle shall be operated in excess of twenty (20) miles per hour on said portions of Carlisle Street and Indiana Street.

SECTION II.

That the Town Marshall, or any other person designated by the Town Council of the Civil Town of Mooresville, shall cause the speed limit to be posted with the appropriate sign stating the speed limit on Carlisle Street and

Indiana Street in areas above as twenty (20) mile per hour speed limit “when children are present”.

SECTION III.

Ordinance No. 14-1973 is specifically vacated and superceded by this ordinance.

SECTION IV.

That violation of this ordinance shall be cited by the Town Marshall or Deputy Town Marshall into the Mooresville Town Court as a violation of this ordinance or any other appropriate court and shall be punishable by fine or not less than Zero dollars (\$0.00) nor more than One Hundred Dollars (\$100.00).

SECTION V.

That an emergency exists necessitation that this ordinance contained herein shall be effective immediately.

Said ordinance passed and adopted this 4th day of August 1992.
