

## ORDINANCE 2-1975

### **AN ORDINANCE ESTABLISHING A RESTRICTED PARKING AREA ON EAST AND WEST SIDE OF NORTH INDIANA STREET FROM MAIN STREET TO WASHINGTON STREET IN THE TOWN OF MOORESVILLE, INDIANA AND PROVIDING FOR A PROVISION FOR REMOVAL OF ANY MOTOR VEHICLE VIOLATING SUCH RESTRICTED TIME LIMITATIONS.**

BE IT ORDAINED by the Board of Trustees of the Town of Mooresville, Indiana, that:

By the powers vested in the said Board of Trustees of the Town of Mooresville, Morgan County, Indiana, by the acts of the General Assembly of the State of Indiana, it is hereby ordered and ordained that whereas it is necessary to restrict and limit by time, parking on the East and West side of North Indiana Street from the intersection of North Indiana Street and West Main Street to the intersection of North Indiana Street with East and West Washington Streets, it is hereby ordered and ordained that an ordinance be adopted establishing a restricted time limit parking zone on and along the East and West side of North Indiana Street, on and along said designated area in the Town of Mooresville, Indiana.

#### Section 1:

Be it hereby Ordered that a time restrictive parking zone be established on the East and West sides of North Indiana Street from the intersection of North Indiana Street with East and West Main Streets, north along the East and West sides of Indiana Street right of way to the intersection of North Indiana Street with East and West Washington Street and it is further ordered and ordained that any motor vehicle parked in said restrictive time limit zone shall be limited to a two (2) hour parking period from 9:00 am through 5:00 pm Monday through Saturday of each week.

#### Section 2:

Any motor vehicle which shall violate the said restrictive parking zone in and along said restrictive areas may be removed and towed away by

the Mooresville Town Marshall or any Deputy Marshall of the Mooresville Police Department by a commercial towing service.

Be it further ordered and ordained by the Board of Trustees of the Town of Mooresville, Indiana, that any such vehicle as shall be towed away for violation of the restrictive parking area as herein specified in this ordinance shall be towed to a place of safe storage and shall not be returned to the owner of such motor vehicle until such time as said owner pays a reasonable commercial tow-in charge and storage expense as may be determined under the circumstances; in addition thereto, such owner of said motor vehicle shall pay the fine assessed as provided for violating such restrictive parking area.

Section 3:

The Town Marshall, or any other person designated by the Board of Trustees of the Town of Mooresville, Indiana, shall post or cause to be posted suitable signs at the aforesaid restrictive time parking zone, such signs to be erected at said restrictive parking area shall also designate the area as a tow-in zone.

Section 4:

Violations of this ordinance is hereby declared to be a misdemeanor punishable by fines of not less than One Dollar (\$1.00) nor more than Twenty-Five dollars (\$25.00).

Section 5:

Whereas an emergency exists, said ordinance is declared to be in full force and effect upon passage of same and the Clerk-Treasurer is directed to publish said ordinance for two (2) consecutive weeks. Any ordinance in conflict with the terms of this restrictive parking zone ordinance is hereby repealed.

Said ordinance passed and adopted this 18<sup>th</sup> day of February 1975.
