

ORDINANCE 22-1978

AN ORDINANCE ESTABLISHING A NO PARKING AREA ON THE SOUTH AND NORTH RIGHT-OF-WAY OF CARLISLE STREET FROM ITS INTERSECTION WITH INDIANA STREET TO THE PRIVATE ENTRANCE TO THE PAUL HADLEY JUNIOR HIGH SCHOOL ON CARLISLE STREET

BE IT ORDAINED, by the board of Trustees of the Civil Town of Mooresville, Indiana, that:

By the powers vested in the said Board of Trustees, by the acts of the General Assembly of the State of Indiana, it is hereby ORDERED AND ORDAINED that whereas it is necessary to control the flow of traffic by establishing a limited no parking zone on the north and south right-of-way to Carlisle Street from its intersection with Indiana Street to the private entrance to the Paul Hadley Junior High School on Carlisle Street, it is hereby ORDERED AND ORDAINED that an ordinance be adopted prohibiting parking in said area during each school calendar year as is or shall hereafter be established on Monday through Friday from the hours of 7:30 am to 2:30 pm.

SECTION I

Be it hereby ORDERED AND ORDAINED that for the control of the flow of traffic in the Town of Mooresville, Morgan County, Indiana, that on the south and north right-of-way of Carlisle Street from its intersection with Indiana Street to the private entrance to the Paul Hadley Junior High School on Carlisle Street during each school calendar year as is or shall hereafter be established on Monday through Friday from the hours of 7:30 AM to 2:30 PM, is established as a no parking zone and that no parking shall be permitted at any such time at and along said right-of-way during such designated school calendar year.

SECTION II

The Town Marshall, or any other person designated by the Board of Trustees of the Town of Mooresville, Morgan County, Indiana, shall post and cause to be posted appropriate signs at and along the aforesaid right-of-way designating such area as a no parking zone at said designated times as is set forth above.

SECTION III

Violations of this ordinance is hereby declared to be a misdemeanor, punishable by fines of not less than One Dollar (\$1.00) nor more than Twenty-Five Dollars (\$25.00).

SECTION IV

Be it further ORDAINED by the Board of Trustees of the Civil Town of Mooresville, Indiana that any motor vehicle which shall violate the no parking zone during such designated periods of no parking along said right-of-way shall be removed and towed away by the Mooresville Town Marshall or any deputy Marshall by a commercial towing service.

Be it further ORDAINED by the Board of Trustees of the Civil Town of Mooresville, Indiana that any such vehicle that shall be towed away for violating the specified no parking area during such restrictive periods as set forth above in this ordinance shall be towed to a place of safe storage and such motor vehicle shall not be returned to the owner until such time as the owner thereof pays a reasonable commercial towing charge and storage expense as may be determined under the circumstances; in addition thereto such owner of said motor vehicle shall pay the fine that shall be assessed as provided above.

SECTION V

Whereas an emergency exists, said ordinance is declared to be in full force and effect upon passage of same and the Clerk-Treasurer is directed to publish said ordinance for two (2) consecutive weeks.

Said Ordinance passed and adopted this 5th day of December 1978.
