

## Ordinance Number 5 - 2006

### **An Ordinance Establishing a No Parking Area on Indiana Street from Washington Street to County Line Road on the East Side and from Carlisle Street to County Line Road on the West Side of Indiana Street in Mooresville, Indiana**

WHEREAS, pursuant to the authority granted to the Civil Town of Mooresville, through its Town Council, to enact certain Ordinances to establish reasonable regulations for the protection of the life, health, safety and property of the citizens of the Town of Mooresville;

WHEREAS, the Mooresville Street Department has determined that there is insufficient room for parking on Indiana Street on the East side of the road from the intersection of Washington Street and Indiana Street to County Line Road and on the West side from the intersection at Carlisle Street to County Line Road;

WHEREAS, it has been determined that parking on Indiana Street in the aforementioned areas would result in safety risks to the public and their property on Indiana Street;

NOW, THEREFORE, BE IT ORDERED AND ORDAINED that an Ordinance be adopted prohibiting parking on Indiana Street from its intersection at Washington Street on the East side of Indiana Street through the intersection at County Line Road and on the West side of Indiana Street from its intersection with Carlisle Street to the intersection of County Line Road in Mooresville, Indiana as more particularly set out herein:

**SECTION I.** That parking on Indiana Street from its intersection with Washington Street to the County Line Road intersection shall be prohibited on the East side of Indiana Street at all times and this area shall be established as a “no parking zone”; further that there shall be no parking on Indiana Street from its intersection with Carlisle Street to the intersection with County Line Road on the West side of Indiana Street and this area shall be established as a “no parking zone.”

**SECTION II.** The Mooresville Street Department shall post this area of Indiana Street on both the East and West side as set out in Section I as “no parking zone”.

**SECTION III.** Be it further ordained by the Town Council for the Civil Town of Mooresville that the Mooresville Police Department is authorized to tow away or remove and tow away by a commercial towing service any motor vehicle violating this Ordinance in the above designated area on the Town of Mooresville right-of-way of Indiana Street as set out in Section I. Any such vehicle towed for violation of the provisions of this

Ordinance shall be towed to a place of safe storage and shall not be returned to the owner of such motor vehicle until such time as the owner pays a reasonable commercial towing charge, any storage expense and in addition thereto, said owner of the vehicle pays a fine that shall be assessed for the parking violation as provided in Section IV of this Ordinance.

**SECTION IV.** Violation of this Ordinance is hereby declared to be punishable by a fine of Twenty-Five Dollars (\$25.00) along with Court costs through the Mooresville Town Court.

**SECTION V.** This Ordinance shall become effective upon the date of passage and first publication. This Ordinance passed and adopted this 2<sup>nd</sup> day of May, 2006.
