

ORDINANCE 6-1972

AN ORDINANCE ESTABLISHING A NO-PARKING AREA ON THE EAST SIDE OF NORTH INDIANA STREET FROM MAIN STREET TO THE FIRST CURB CUT OR ENTRANCE NORTH OF THE INTERSECTION OF EAST MAIN STREET AND NORTH INDIANA STREET IN THE TOWN OF MOORESVILLE, INDIANA

BE IT ORDAINED by the Board of Trustees of the Town of Mooresville, Indiana, that:

By the powers vested in said Board of Trustees of the Town of Mooresville, Indiana by the acts of the State of Indiana (ACTS 1965, Chapter 129 and all amendments thereto) it is hereby ordered and ordained that whereas it is necessary to control the flow of traffic in the Town of Mooresville, Indiana, on North Indiana Street by establishing a no parking zone on the east side of North Indiana Street beginning at a point on the northeast corner of the intersection of East Main Street and North Indiana Street and thence running north on and along the east side of North Indiana Street to the first curb cut or entrance north of the said intersection from 8:00 AM to 7:00 PM on each Friday and from 8:00 AM to 12:00 AM on each Saturday. It is hereby ordered and ordained that an ordinance be adopted prohibiting parking along said area during said days for said times.

Section 1:

It is hereby ordered and ordained for the control of traffic on the east side of North Indiana Street beginning at a point on the northeast corner of the intersection of East Main Street and North Indiana Street, thence running north on and along the east side of North Indiana Street to the first curb cut or entrance North of said intersection of East Main Street and North Indiana Street be and it is hereby established as a no-parking zone from 8:00 AM to 7:00 PM on each Friday and from 8:00 AM to 12:00 AM on each Saturday, at and along said area on the East side of North Indiana Street.

Section 2:

The Town Marshall or any other person designated by the Board of Trustees of the Town of Mooresville, Indiana, shall post or cause to be posted suitable signs in the aforesaid area designating that the same is no parking area during such periods as heretofore set out.

Section 3.

Violation of this ordinance is hereby declared to be a misdemeanor punishable by fines of not less than One Dollar (\$1.00) or more than Twenty-Five Dollars (\$25.00).

Section 4:

Whereas an emergency exists, said ordinance is declared to be in full force and effect on passage of same and the Clerk-Treasurer is directed to publish said ordinance for two (2) consecutive weeks.
