

ORDINANCE 8-2003

AN ORDINANCE ESTABLISHING A NO PARKING AREA ON THE WEST SIDE OF JEFFERSON STREET FROM WASHINGTON STREET TO MORGAN STREET

WHEREAS, pursuant to the authority granted to the civil Town of Mooresville by its legislative body the Town Council to enact certain Ordinances to establish reasonable regulations for the protection of life, health, safety and the property of the citizens of the Civil Town of Mooresville;

WHEREAS, it is necessary to establish regulations as to parking along the streets and highways controlled by the Town of Mooresville;

NOW, THEREFORE IT IS HEREBY ORDERED AND ORDAINED THAT:

Section I. An Ordinance be adopted prohibiting parking on the West side of Jefferson Street between the intersection of Jefferson Street with Morgan Street and Washington Street. Parking shall be prohibited on the West side of Jefferson Street from the intersection of Washington Street through the intersection of Morgan Street.

Section II. The Police Chief, Street Commissioner or other person designated by the Town Council shall be responsible for posting or causing to be posted signs at the aforesaid area of Jefferson Street designating the “no parking zone”.

Section III. BE IT FURTHER ORDAINED by the Town Council for the Civil Town of Mooresville, Morgan County, Indiana that the Mooresville Police Department is authorized to tow away or have removed and towed away by a commercial towing service any motor vehicle violating this Ordinance in the above designated area on the Town of Mooresville right-of-way located on Jefferson Street as described in Section I. Any such vehicle towed for violation of the provisions of this Ordinance shall be towed to a place of safe storage and shall not be returned to the owner of such motor vehicle until such time as the owner pays a reasonable commercial towing charge, any storage expense as charged by the service

contacted by the Town to remove the vehicle. In addition, the owner of the vehicle shall be subject to the fines set out in Section IV of this ordinance.

Section IV. Violation of this Ordinance is hereby declared to be punishable by a fine of not less than One Dollar (\$1.00) nor more than Twenty-Five Dollars (\$25.00) and shall be enforced by a ticket on a uniform traffic ticket citation directing the violator to the Mooresville Town Court.

Section V. Whereas an emergency exists, this Ordinance is declared to be in full force and effect from and after its passage and publication. All Ordinances and parts of Ordinances conflicting with this Ordinance are hereby specifically repealed in whole or in part.
