## PROPERTY DESCRIPTION

Under Ind. Code § 5-22-22-5, the Town of Mooresville, Indiana ("Town") is seeking sealed bids for a 2004 Freightliner/EVI Medium Duty Rescue/TSU ("Squad"). The Squad is owned by the Town and is currently located at Mooresville Station 1, 415 E. State Road 144, Mooresville, IN 46158. A specific description of the Squad is included below:

- Make and model: Freightliner / EVI Medium Duty Rescue
- Year: 2004
- Color: Red
- VIN: 1FVAGXCS44HM17957
- Mileage: 46285
- The Town's decal, siren, and radio will be removed from the Squad.

If required by law or upon the successful bidder's request, the successful bidder shall remove the lamps from the Squad. A successful bidder who requests such accessories to remain on the Squad will agree to indemnify and hold harmless the Town for any actions or damages that may result.

Interested bidders may make an appointment for inspection of the Squad.







### **SEALED BID GUIDELINES**

The minimum bid is set at \$30,000.00 ("Minimum Bid"). All bids shall be submitted via mail or hand delivery to Moorsville Town Hall, 4 E Harrison St. Moorsville, IN 46158, on or before June 30, 2021 at 4:30 p.m. EST. Bids received after this time will not be accepted.

All bids shall be submitted in a sealed envelope labeled with the following: (1) Request for Sealed Bids-2004 Freightliner/EVI Medium Duty Rescue; and (2) the bidder's name and address.

All bids shall include a completed Bid Form (included in this Request for Sealed Bids). No bid shall be accepted if not submitted on the Bid Form, a submission of which constitutes a legally binding offer by the respective bidder. Any bidder desiring to raise its bid must submit a new Bid Form.

No bid security or bid bond is required.

A bidder shall have no right to assign its bid prior to closing without the express written consent of the Town. Any such assignment shall not release a bidder from the terms and conditions of its bid.

Bidders will be required to indicate whether Indiana law requires them to remove the Squad's lamps and will agree to hold the Town harmless from any actions or damages if these accessories remain on the Squad.

### **SALE INFORMATION**

All sealed bids shall be opened at a public meeting of the Town of Mooresville Council on or after July 6, 2021. The Town of Mooresville reserves the right to:

- Cancel the bidding process and reject any and all bids;
- Waive informalities and irregularities;
- Reject any bid that is incomplete, illegible, inadequate, or unresponsive;
- Seek or provide clarification or conduct discussions at any time with bidders; and/or
- Award sale of the Squad to the highest responsible bidder.

The Town is selling the Squad "as is". The Town will not provide any financing for the purchase of the Squad. All financing must be independently secured with payment made in full to the Town at or before the time of sale by a payment method acceptable to the Town. Transfer of title to the Squad shall be by quitclaim bill of sale, and there are no warranties of any kind. The successful bidder shall be responsible for reporting any applicable sales tax.

Closing on any sale is anticipated to occur within 30 days of the bid deadline indicated below and shall be subject to final approval by the Town. Delivery of the

Squad is the responsibility of the successful bidder and shall be made at such bidder's sole expense.

The condition of the Squad is subject to normal post-inspection wear and tear.

### MISCELLANEOUS

By submitting a bid, each bidder agrees that any action relating in any way to the bid process shall be brought either in an Indiana state court located in Morgan County, Indiana, or the United States District Court for the Southern District of Indiana. Indiana law shall govern all actions.
